Decree No. 907 of the Year 2019

On Imposing Final Precautionary Measures on Imports
of Iron or Steel Bars and Rods (Reinforcing Steel For Building Purposes)
Item, and Semi-finished Products of Iron or Non-alloy Steel (billets) Item

After reviewing Law No. 161 of the year 1998 concerning the Protection of the National Economy against the Effects Resulting from the Harmful Practices of International Trade,

The Executive Regulations of Law No. 161 of the year 1998 promulgated by Ministerial Decree No. 549 of the year 1998,

Ministerial Decree No. 569 of the year 2008 on amending certain provisions of the Executive Regulations of Law no. 161 of the year 1998, referred to,

Upon the report of the Advisory Committee,

And upon the proposition of the Commercial Treatment Sector,

DECREES THE FOLLOWING:

Article – 1

Imports of certain items of iron and steel products shall be subject to a final precautionary measures duty for a three-year period, including the temporary precautionary measures period, as follows:

First: Rods and bars of iron or non-alloy steel formed as bars and rods hot-rolled in wound coils (reinforcing steel for building purposes), which are included under HS Code (7213) and HS Code (7214) of the harmonized Customs Tariff.

Year	From 12/10/2019 to 11/4/2020	From 12/4/2020 to 11/4/2021	From 12/4/2021 to 11/4/2022
Value	(25%) of the Value (CIF), at a minimum of 125 US Dollars/ ton	(21%) of the Value (CIF), at a minimum of 105 US Dollars/ ton	(17%) of the Value (CIF), at a minimum of 85 US Dollars/ ton



Second: the semi-finished products of iron or non-alloy steel (billets), which are included under HS Code (7207) of the harmonized Customs Tariff.

Year	From 12/10/2019 to 11/4/2020	From 12/4/2020 to 11/4/2021	From 12/4/2021 to 11/4/2022
Value	(16%) of the Value (CIF), at a minimum of 74 US Dollars/ ton	(13%) of the Value (CIF), at a minimum of 60 US Dollars/ ton	(10%) of the Value (CIF), at a minimum of 46 US Dollars/ ton

Article - 2

The aforesaid duties shall be collected under the Export Development Fund Account (Treasury Single Account) – institution code: 32101901.

Article – 3

The present decree shall be published in Al-Wakaye Al-Mesreya/ Government Bulletin, and shall come into force as of 12/10/2019.
